Motion Hardenbrook to approve purchase of all needed road signs: 4 'Private Road, Vehicle Code Enforced'; 3 directional arrows for detours; 2 'Road Subject To Flooding'; 3 stop signs for blind intersection at Stable and Sunview; 2 'Road Work Ahead' plus stands; 1 Fernhill Drive street sign replacement. Not to exceed \$1400.00. Leonard 2nd Motion carried unopposed
